and school leaders will gather for the group's annual kickoff the evening of October 3 at the home of Founder and President Lucas Fleming and his wife Tara Fleming.

St. Petersburg Mayor Bill Foster who is also an attorney will be on hand to wish the group well on the start of their 11th year of tutoring public school children in reading.

Foster will also share thoughts about the importance of literacy to the community that have come from his years of advocating for excellence in education including his new initiative, St. Pete's Promise, which brings The City of St. Petersburg, Pinellas

County Schools and others together in support of improvement in local education.

The event also will give the opportunity to recognize Christine Derr, CeCe Ingle, Nancy Harris and Barbara Pritchett for five years of tutoring with LFL.

St. Petersburg's Campbell Park, Jamerson and Sanderlin elementary schools will receive five year awards for serving as host schools.

School sponsors for 2014 and corporate sponsor **LexisNexis** will be recognized.

The Lawyers for Literacy event marks the start of a three month search for

additional tutors to assist in 14 Pinellas and Hillsborough elementary schools beginning in January and carrying through to early April.

Funds also are being sought to purchase the needed books, reading improvement materials, and supplies used by what is expected to be 150 students this school year.

LFL Students Advance: Tutoring Made

94% of Students Tutored Promoted to 4th Grade

Statistics show that students who may not have advanced to 4th grade because of low reading skills benefited from LFL tutor assistance.

94% of students tutored last school year improved and were promoted. Tutors and their third grade students focused on preparing for the reading portion of the required Florida Comprehensive Assessment Test (FCAT).

Tutoring took place once a week over three months in advance of the FCAT which, for third graders, is the first time they are faced with a single test that largely determines whether they will be promoted to fourth grade. •

Donations Make It Possible

Each year donations allow LFL to continue to answer calls for assistance from elementary schools served previously and make it possible to consider serving additional schools.

LFL tutors worked with 120 students at 11 schools in the spring of 2013. An estimated 150 student—tutor pairs will be in action starting in January 2014 at 14 schools assuming necessary funds can be found.

Books at five elementary schools are thus far sponsored by: Peter & Marion Fleming, Jeanette Secor, Scott Wagman & Beth Houghton, Bill Weller & Cynthia Smoot-Weller and the Walmart Neighborhood Market in Largo, FL.

School sponsors are being sought for the remaining schools.

First time support has come from Hillsborough County Sheriff's Office Charities as part of their Community Outreach Division headed by Major Sankar Montoute.

Key contributions for the 2014 tutoring season have been received from the **St. Petersburg Bar**

Foundation and corporate sponsor **LexisNexis**.

Much appreciated also is support coming for the first time from the St. Petersburg chapters of the **Kiwanis** and **Rotary** community service organizations.

Eighteen tutors have come forward from the Hills-borough County Public Defender's Office, under Public Defender Julianne M. Holt, to help students at four Tampa elementary schools.

The PD13 office response was the largest from any one organization and enabled Lawyers for Literacy to send 33 tutors in all to Rampello

Downtown K-8 Magnet School, more than double the number at other schools.

Ashley Roura who led recruitment efforts said "We had an immediate and wonderful response in our office to LFL's call for volunteer tutors."

Roura's husband Miguel, an attorney with Banker Lopez

Gassler in Pinellas County, tutors with Lawyers for Literacy and reccommended it to his wife.

"Our office always looks for opportunities to give back to our community. LFL tutoring was very rewarding and we were honored to be involved in the program" Ashley Roura said.
